

It has been an absolute honor to serve as the Western District Vice President this year. This has been one of the most intimidating, but fulfilling, things I've been able to be a part of.

One of my main goals as Vice President this year was to consolidate information about general chapter recruitment timelines in the Western District. We are an extremely unique district for many reasons. One of those reasons is the fact that we have a pretty even split between quarter schools and semester schools which really affects the number of times chapters can recruit. I wanted to gather all of this general timeline information to help future vice presidents as they think about their programming for VPMs. Most of our quarter school chapters don't even begin to tackle ritual and the Road to Wisdom until the second half of the year while semester school may take an entire class through the membership process during their fall term. I also really focused on trying to build individual connections with chapter VPMs through one-on-one meetings. I wanted VPMs to know that I would do everything I could to help them have a successful time recruiting.

Another project I started was focused on building relationships with alumni relations officers in hopes of making sure all of the required chapter officers have a counterpart at the district level in the future. I was able to gather some information on how other chapters utilize alumni relations officers. *Charges:*

- 1. Build connections with your VPMs and foster brotherhood between VPMs.
- 2. Take time to figure out what meeting style works for you and the VPMs and what allows you all to have productive conversations about all things recruitment and membership.

To the 2023-2024 Western District Council:

1. Believe the governors when they tell you this year will go by in the blink of an eye. I swear it was August like two weeks ago.

2. Support each other to the fullest extent. You will be each other's greatest resources as you navigate the chaos that is being a district officer. Help each other be the best officers you can be.

#### **Description**

Voting on matters, as needed, will come from the committee representatives listed above. This committee will work separately with members of chapters of Kappa Kappa Psi from the Western District, and communication will happen as needed with our Sister Counterparts through the WD Parliamentarian Goals

- As stated in the 2022 Kappa Kappa Psi Western District Constitution, Article VIII, Subarticle 8.101:
  - The Jurisdiction Committee shall:
    - Review proposed Changes to the Kappa Kappa Psi Western District Constitution
    - Review the document for grammar and spelling mistakes
    - Investigate opportunities to consolidate redundancies
    - Fix discrepancies and contradictions, paying close attention to constitutionality
- Additionally, the Parliamentarian will follow Article II, Subarticle 2.3.1

- The Parliamentarian shall be responsible for publishing an amended version of the Western District Constitution to the District Webmaster and the District Secretary-Treasurer forty-eight (48) hours after the conclusion of the Western District Convention.

#### Discussion

Recommendation 1: Define absolute majority. This concept is not mentioned in Nat Con, nor is it a term in Robert's Rules. Maybe in the future we could reword this all together, but for now this gets the point across well enough.

- 10.1.2 If the favorable vote on a proposed amendment is less than three-fourths (3/4), yet there is an absolute majority vote (favorable majority of all membership), the proposed amendment shall be postponed until the next regularly called Convention of the District.

#### Charges for Western District Convention 2024

To the Jurisdiction Committee:

- Review the past reports and charges as a committee so that everyone knows what needs to be accomplished.
- Take the time to comb through the Constitution to ensure it is as concise and consistent as possible.

To the Parliamentarian:

- Find a way to get your committee members to either show up actively to your meetings, or find a
  way to communicate with each member closely with assignments that can be completed
  asynchronously.
- Communicate early and often with the District Officers and advisor(s). They can make your life a lot easier.
- Be sure to ask your District President for adequate resources to do your job well

#### To Whom it may Concern:

- Always review the national constitution beforehand and in conjunction with our western district BYLAWS (with you all the way, Brain Parker)

# Preamble TO THE WESTERN DISTRICT CONSTITUTION OF KAPPA KAPPA PSI

NATIONAL HONORARY BAND FRATERNITY

Be it known that Kappa Kappa Psi, National Honorary Fraternity for College Bandmembers, is an organization operating exclusively in the field of the college and university bands, and for the following several purposes:

- To promote the existence and welfare of the college and university bands and to cultivate at large a wholesome respect for their activities and achievements.
- To honor outstanding bandmembers through privilege of membership extended as a reward for technical achievement and appreciation for the best in music.
- 3. To stimulate campus leadership and promulgate an uncompromising respect through the

- medium of the college band for gracious conduct, good taste and unswerving loyalty.
- 4. To foster a close relationship between college bands and promote a high average of attainment by the performance of good music and selection of worthwhile projects.
- 5. To provide a pleasant and helpful social experience for all engaged in college band work and to cooperate with other musical organizations in any manner consistent with the purposes of the institution at which chapters are located

#### I. General

- 1.1 The name of the District shall be Western District, in accordance with the National Constitution of Kappa Kappa Psi, National Honorary Band Fraternity.
- 1.2 The Western District shall be composed of all chapters in active standing with the National Headquarters in the states of Alaska, Arizona, California, Hawaii, Idaho, Nevada, Oregon, Utah, and Washington, and any other chapters as determined by the National Council and the National Constitution.
- 1.3 The National Constitution and any rules and edicts of the National Chapter and National Council shall take precedence over this Constitution.
- 1.4 The Purposes of the Western District shall be consistent with those of the National Chapter.
- 1.5 The Kappa Kappa Psi Western District Constitution is to be used in conjunction with Section V of the National Constitution.
- 1.6 The Western District of Kappa Kappa Psi recognizes The Western District of Tau Beta Sigma as an equal affiliated organization with a parallel purpose, function, and role in the college and university band setting.
- 1.7 A District year is defined as the time between the adjournments of Western District Conventions.

#### II. Officers

- 2.1 Elected Officers The District Council shall consist of the District President, Vice President, Secretary-Treasurer, and Member-At-Large. The District Council will be responsible for governing the District and overseeing all of its affairs.
  - 2.101 In addition to the duties stated in the National Constitution, the duties of the Western District President shall be as follows:
    - a. The President shall communicate upcoming district events, district resources, and district council summary of activities.
  - 2.102 In addition to the duties stated in the National Constitution, the duties of the Western District Vice President shall be as follows:

- a. The Vice President shall act as a point of contact for the officer(s) in charge of matters relating to education, including but not limited to, membership education, recruitment, continued membership education, and ritual education, in order to assist in the development of their programming as needed throughout the year.
- b. The Vice President shall be the point of contact for Western District Petitioning Groups.
  - 2.103 In addition to the duties stated in the National Constitution, the duties of the Western District Secretary-Treasurer shall be as follows:
    - a. The Secretary-Treasurer shall maintain a ledger of the Western District's income and expenditures.
  - 2.104 In addition to the duties stated in the National Constitution, the duties of the Western District Member-at-Large shall be as follows:
    - a. The Member-At-Large shall assist the District with communication between all chapters and petitioning groups in the District, with an emphasis on service and brotherhood. They shall oversee and organize recurring programming for the district, including, but not limited to district activities, workshops, podcasts, awards, and email listserv.
    - b. The Member-at-Large shall be responsible for the promotion of all District awards and for the distribution of each award application to the District no later than fifteen (15) days before each application deadline.
- 2.2 Rules for Elected Officers All elected officers must be active members in full standing at the time of election and for the duration of their time in office.
  - 2.201 Officers shall create and/or maintain transition materials to provide to the officers-elect in order to facilitate a smooth transition between officers.
  - 2.202 Each officer shall serve no more than two (2) consecutive District year terms in the same office.
  - 2.203 Each District officer shall contact their corresponding Chapter officers a minimum of two (2) times during the first six (6) months of office, and a minimum of two (2) times during the second six (6) months of office, as described below:
    - a. The President shall contact the Presidents, the Vice President shall contact the

officers in charge of membership, the Secretary-Treasurer shall contact the Secretaries and Treasurers, and the Member-At-Large shall contact the service chairs of all chapters and petitioning groups.

- 2.204 A District Officer shall be removed from office following a submitted request from a chapter, District Officer, or District Governor, if sufficient grounds exist to remove the officer according to the following procedures:
  - a. A formal complaint against the Officer in question must be sent to the District Governor(s). Said complaint must contain a complete list of charges and grievances against the Officer, with documentation.
  - b. After receiving a formal complaint, the District Governor(s) shall mediate an impartial and balanced review of the charges and grievances against said Officer. Following the review, a two-thirds (2/3) vote from the remaining voting members of the District Council, as well as the approval of the District Governor(s), shall be necessary for the impeachment of the Officer. After such impeachment, the District Governors shall submit a detailed report of the allegations, evidence, analysis, and judgment to the active chapters of the District.
  - c. Following the distribution of the impeachment report, active Chapters of the District shall have fourteen (14) days to submit a vote on the impeachment. A two-thirds (2/3) majority confirmation vote amongst the Chapters shall be sufficient to remove the Officer from office. If an active Chapter does not submit a vote within said fourteen (14) days, it will be assumed that said chapter abstains from the impeachment process.
  - d. Upon removal, the Office in question shall be declared vacant and regular procedures to fill a vacancy shall commence.
- 2.205 If a vacancy occurs in a District Office, the vacancy shall be filled according to the following procedures:
  - a. In the event that a District Office is left vacant by election or vacated midterm, all chapters, for a period of ten (10) days, may submit to the remaining District Council suggestions and candidates to fill the vacancy. The District Council shall notify all Chapters of the application process.
    - i. If the office of District President is vacated midterm, the District Vice President shall automatically succeed to the District Presidency until the next Western District Convention.
    - ii. If a vacancy occurs in any other District Office, the District President

- shall immediately notify all chapters of the vacancy according to the procedure described above.
- b. After the above stipulated ten (10) days, the District Council shall deliberate and then appoint a candidate to fill the vacant office.
- c. The appointed candidate shall take office upon approval of the District Governor(s) and a simple majority of all active chapters in the District within fifteen (15) days of appointment.
  - i. If an active chapter does not submit a vote within said fifteen (15) days, it will be assumed that said chapter abstains from the appointment process.
  - ii. The Active Chapters will be provided with the candidate's packet at the beginning of this fifteen-day period.
- 2.3 Appointed Officers The Western District shall appoint a Parliamentarian.
  - 2.301 The Parliamentarian shall serve as a parliamentary procedure advisor to the District and chair the Jurisdiction Committee.
    - a. The Parliamentarian shall be appointed by the District Council after all the submitted applications have been reviewed by the District Council no later than three (3) weeks before the District Convention.
    - b. The Parliamentarian shall be an active member and shall not be a voting member of the District Council.
    - c. The Parliamentarian shall be responsible for publishing an amended version of the Western District Constitution to the District Webmaster and the District Secretary-Treasurer forty-eight (48) hours after the conclusion of the Western District Convention.

### III. Nominations and Elections

- 3.1 Elections for the Western District President, Vice President, Secretary-Treasurer, and Member-at-Large shall be held annually at the District Convention.
- 3.101 The President, aided by the District Council, shall facilitate Officer Candidate applications.
  - 3.102 The President shall ensure that completed officer candidate applications are made available to the Western District forty-eight (48) hours prior to the start of convention.

- 3.103 Candidates for District Office must submit the following:
  - a. A written application, stating office sought, as distributed by the Western District Council.
  - b. A brief written recommendation, signed by one chapter executive officer, stating the candidate's status within the chapter and expressing chapter support for the candidate.
  - c. A written recommendation from the Chapter Sponsor, Director of Bands, or Director of Athletic Bands verifying the candidate's academic standing.
- 3.104 A simple majority of votes cast shall be necessary for election.
- 3.105 Options for voting in elections include any nominated candidate and leaving the office vacant.
- 3.106 If no candidate receives a simple majority vote, a runoff election shall commence between the two highest vote-getters.
- 3.107 In the event of a tie after the second ballot, the office in question shall remain vacant, and the normal vacancy procedures shall commence after the conclusion of the Convention.
- 3.2 The procedure for selection of Honorary members of the Western District of Kappa Kappa Psi shall be as follows:
  - 3.201 Nominations from any member of the Western District of Kappa Kappa Psi shall be sent to the Western District President to be approved by a seventy-five (75) percent favorable vote of the Western District Council.
  - 3.202 Any financial obligations, if applicable, for the installation of an Honorary member shall be borne by the Western District of Kappa Kappa Psi.

### **IV. Joint Organization Operations**

- 4.1 The Joint Western District Council shall be made up of elected officers from both organizations as outlined in article 2 of the respective Western District Constitutions of Kappa Kappa Psi and Tau Beta Sigma.
  - 4.101 A passing vote in Joint District matters shall require a simple majority approval from

both separate councils.

### 4.2 Joint Western District Webmaster shall:

- 4.201 Be an active or associate member of either organization and appointed by the Joint District Council after all the submitted applications have been reviewed by the Joint District Council.
- 4.202 Provide publishing access for the Western District Website to the officers of the Joint Western District Council.
- 4.203 Maintain the layout, content, and security of the Western District website.
- 4.204 Be responsible for updating the website within one (1) week of major events or requests.
- 4.205 Submit a summary report to the Joint Western District Council when major changes are made to the website and must log minor changes in a report to be submitted at year end.

### 4.3 Joint Western District Publisher Shall:

- 4.301 Be an active or associate member of either organization and be appointed by the Joint District Council after all the submitted applications have been reviewed by the Joint District Council.
- 4.302 Be responsible for designing, assembling, and publishing the Fall and Spring packet.
  - 4.303 Distribute a minimum of one (1) copy of The Accent "Best Of" Edition per District Officer, District Webmaster, Governor or Counselors, Chapter, and Petitioning Groups of both organizations in the Western District as well as National Officers.

### V. Finances

- 5.1 In the event that a chapter misses the deadline for an annual dues payment, they shall pay a fine to the Western District of Kappa Kappa Psi equal to the amount of money lost by the District in allotments that resulted from tardiness.
- 5.2 At the discretion of the District Governor(s), any chapter not fulfilling its financial obligations to

the District shall be denied a delegate seat at the District Convention.

5.3 Before a District Officer can make a purchase for which they shall request a reimbursement from the district, they must get the approval of the District Governor(s) and the rest of the District Council. If prior approval is not granted, the officer shall be financially responsible for the purchase.

# VI. Meetings

6.1 A regularly called convention of the District shall be held every year. It is recommended that all National Officers, District Officers, and guests be recognized before seating of the delegates.

# VII. Delegates and Delegate Proxies

7.1 If a chapter is not represented by a delegate or written proxy, then a proxy shall be assigned by the District President according to Greek alphabetical order. Alphabetical Order shall pick up from the last proxy sat.

### **VIII. Committees and Committee Representative Proxies**

- 8.1 The following standing committees shall function at or prior to each District Convention: Jurisdiction Committee, Nominations Committee, and the Ways and Means Committee.
  - 8.101 The Jurisdiction Committee shall review all proposed changes to the Kappa Kappa Psi Western District Constitution, review the document for grammar and spelling mistakes, investigate opportunities to consolidate redundancies, and fix discrepancies and contradictions.
  - 8.102 The Nominations Committee shall recommend to the delegation a suitable candidate for each District Office in the form of a slate. In the event that the committee does not find any of the candidates suitable for a District Office, the slate for that office shall remain open. The Nominations Committee shall also make recommendations to the Jurisdiction Committee outlining the roles and responsibilities of the District Officers.
  - 8.103 The Ways and Means Committee shall examine the annual budget proposed and drawn

up by the Western District Secretary-Treasurer with the purpose of handling discrepancies and financing special projects. It will be the responsibility of the Committee to review the budget proposals and to submit their recommendations to the Secretary-Treasurer for approval.

- 8.2 Each chapter shall have a voting member on every standing committee, unless that chapter chooses not to do so.
- 8.3 In the event that a chapter is not able to fill a position on a standing committee session and has not opted out in advance, a proxy shall fill the position based on the proxy form.
  - 8.301 If said chapter has not filled out a chapter proxy form, then a proxy shall be assigned by the District President according to Greek alphabetical order. Alphabetical order shall pick up from the last proxy assigned.
  - 8.302 Committee representative proxies must be an active, associate, or life member of the Fraternity.
  - 8.303 Once assigned, the proxy committee representative shall serve on the committee for the duration of the convention at the discretion of the Committee Chair.

### IX. Reports

- 9.1 Each District Officer and Chapter Delegate shall submit a report at District Convention. These reports shall be submitted in accordance with the host chapter's requirements for reproduction to the District Secretary-Treasurer, who shall be responsible for reproducing and forwarding copies as necessary. The District Secretary-Treasurer shall forward a copy to the District Governor(s), the National Executive Director, and also retain a copy for the convention minutes.
- 9.2 The host chapter shall submit a report on convention expenses for inclusion in the minutes.

### X. Amendments

- 10.1 Any part of this Constitution may be amended at any time by a three-fourths (3/4) vote of all eligible voting chapters of the District.
  - 10.101 If three-fourths (3/4) of the votes cast by the Convention are favorable, the proposed amendment shall be declared adopted. After such adoption, the amendment shall become

operative and effective at the conclusion of the convention unless otherwise noted.

10.102 If the favorable vote on a proposed amendment is less than three-fourths (3/4), yet there is an absolute majority vote (favorable majority of all membership), the proposed amendment shall be postponed until the next regularly called Convention of the District.

# Goals

#### Discussion

The Ways & Means Committee met virtually, over the phone, communicated via email, and in person prior to WDC. My advisor Eric Morson and I spoke over the phone, as well as in person, overviewing the budget and determining any major roadblocks, most specifically awaiting information on our District Allocations.

The virtual committee meeting began with introductions and was followed with an overview of the current budget, proposed budget, and a document of outlines for changes to the proposed budget. This was done with charges from the 2021-2022 Secretary-Treasurer in mind as well as a realistic overview of the financial standing of the District and Chapter involvement.

We then analyzed the current budget and made proposals, including detailed explanations as to why each change was necessary, both on the revenue and expense side, and further explained why changes were made on each side to keep each one balanced.

Allocations for Fall 2022 came in at about half of the amount that was expected. Allocations come from on-time membership dues, which can vary due to amounts of membership candidates taken in during the term, Chapters taking in classes when they are expected to, as well as the amount of Chapters paying dues on time. This outcome comes down to the need for timeliness and diligence with paperwork on all levels, directly having a consequence on the financial wellbeing of the Western District and our ability to serve. This shortcoming in District Allocations created a rather conservative proposed budget, but by utilizing fundraisers and the prominence in supporting our Chapters and District, this is not expected to be a problem.

The goal of this Committee was to find ways to maintain balance in both revenues and expenses, while

being realistic and focused on the current District ambience. Our plans for fundraising were to better utilize the annual Practice-A-Thon fundraiser as a means of raising most of our money outside of Allocations and other profit-shares, and charging the next Secretary-Treasurer with a goal to raise the set amount, if not more, as well as better utilizing fundraisers in general. The biggest point of discussion regarded District Travel Reimbursement, which eventually decided the leave at the current state due to the existing nature of our budget and needs to remain balanced. Although travel prices remain uncertain, this proposed amount covers \$650 per Officer for the year. This amount can be changed moving forward as financial stability is maintained as well.

Those who were unable to attend the virtual meeting were sent an email with an overview of the current budget, proposal, and rationale. Once their approval was received, the Committee was adjourned, and charges were left up to the Secretary-Treasurer.

### Charges to the 2023-2024 Ways and Means Committee

- Make sure that proposals from this year and committee are still applicable to the 2023-2024 year. Keep in mind changes that are out of your control and the best way to respond.
- Create a baseline to evaluate the success of fundraisers.
- Evaluate the last year's fundraisers and perform a cost benefit analysis.

I would like to start by thanking my advisor Eric Morson for another year of dedication to the District by serving as an advisor of this committee. Your knowledge, passion, and kindness helped pave the way for a successful financial basis for years to come. We may have encountered difficulties with meeting times and technological issues, but your voice, input, and decisions are the reason we are successful today. ### Introduction and Operations

This year has been a test of Alpha Alpha's resiliency. After most of our Active membership graduated last year, we were left with a fairly blank slate to rebuild from. Because we did not have many returning Brothers to pass down knowledge, our primary goal became improving our documentation. This year we drastically improved the detail recorded in our meeting minutes and budget in order to provide meaningful information for future iterations of the Chapter to use and began creating guides for how to hold several of our projects/events. We created several new policies to improve Chapter operations, such as internal control policies to secure our finances and clear communication standards, and reviewed existing policies to ensure they still serve us in our current state. We also became much more proactive with our paperwork, earning Early Bird recognition for our Chapter Personnel Report at the beginning of the year and remaining one step ahead of our Associated Students, asking them how to handle on-campus matters before they even reached out to student organizations.

### Membership Education

During the Fall semester, we were fortunate enough to welcome three amazing new Brothers into our Chapter. Although we did not have a membership class in the Spring semester, we were thrilled to see two of our newly initiated Brothers step up into Executive Board positions and fully commit to their newfound place in the Fraternity. We can not wait to see what else they will achieve in their time as Active Brothers. We continue to strive to improve our recruitment efforts and hope to increase our Chapter size in the next year.

### **Finance**

This year we learned a lot about how to better utilize campus resources to fund Chapter operations. Although we were not able to follow through on our goal of using Club Support Funding from the University, we learned a lot about how to apply for support and how far in advance we need to do that. This has set us up to be able to utilize these resources next year and beyond. We also set up internal control policies to help us safeguard our money both now and in the future and improved upon past fundraisers to turn a much higher profit. Every year we sell t-shirts at Sierra Band Crusade, the high school marching band competition hosted on our campus, and this year rather than hold pre-orders for shirts based on our school's show we had generic SBC shirts available for purchase at our table. Between having immediate availability, the appeal to all audiences, and getting the shirts donated from a parent, we nearly tripled our profit from this event. We continue to strive to build upon past fundraisers and

implement new ones in order to better support our band programs, Chapter operations, and Brothers' participation at all levels of the Fraternity.

#### Service

With only 4-5 Active members, we struggled to combine our manpower to complete many service projects this year. One of our successful projects was cleaning practice rooms before fall juries. When we did this, we left positive/motivational post-it notes in the rooms and on doors of faculty offices, and so many people reached out to say that it was a boost they truly needed. Some of them are even still up in the buildings! We also host our marching band banquet at the end of every season, and this year was our most successful one yet! We booked a venue with a capacity just over our usual maximum attendance, and ended up selling out of tickets! If anyone is looking for a theme to get people to their events, Shrek works very well. Although several of our other ideas were not able to come to fruition this year, we have documented details in order to use them in the future. We also brought back "service questions" during meetings, which ask Brothers to reflect on how we are doing with our service and ways that we can improve each week. We have also begun the long process of digging through pre-covid meeting minutes to find details of old projects and are looking to our five purposes, ritual, and other guiding statements to find ways to better live up to the ideals of the Fraternity through our service.

### Alumni and District Involvement

This year we updated our Alumni policy to be much more inviting, which resulted in Brothers who we have not seen in years attending Ritual. We hope to use these more open channels of communication to see more AA and local Alumni Brothers and gather information on projects and events that they found particularly meaningful during their time as Actives. We also increased our involvement at the District level this year. Although we only have one representative at Western District Convention, we had more Brothers who planned to attend before personal matters interfered, our officers increased communication with their District counterparts, we increased participation in Snarky's Challenge, and Brothers attended District and National events online whenever we were informed and able. We are currently working to try to get more than one representative to the National Convention in Orlando this summer.

### Conclusion

While we still have a long way to go, Alpha Alpha has made great strides toward future success this year. It has been taxing on all of our members, but our ambition has led us to persevere, prepare for the future, buy in to our duty to uphold the ideals of the fraternity, develop a connection with each and every Brother at an individual level, and foster a love for this organization. We may not yet be where we want to be, but we continue to strive to be better. Our heads are bloody, but unbowed. We look to the future

with hope, and we look to our Brothers in the West and beyond for continued inspiration to Strive for the Highest.

### Recruitment

We opted to put through only one class this year as we were okay on numbers, and got 11 new faces to help us through this next year. We did a couple of joint recruitment events with TBS in the fall which was a good way to get our name out there despite not actively recruiting. We have lost a few members to going conditional this year, so we will probably run two classes next year in order to actually grow in numbers. Doing soft recruitment was still very valuable, as it gave us a good idea of who to hard recruit when the time comes to actually do so. Even with two classes, this can still be done on those who would not yet be eligible to join such as freshmen, helping us get their interest early.

### Events

We revived Big Band Bash this past February, and it was mostly a success, despite losing us a bit of cash. BBB is a swing dance hosted on campus, and the jazz band was paid to play there, and we hired a local swing dance group to teach a lesson. It was a lot of fun, but there were some real lessons learned on what was and what was not worth the money. To make it easier on future chapters, a lesson learned document was created detailing our experience so they know what to do, who to call, and what actually works. We plan to work on getting the word out better to increase attendance, as this would serve as a good way to get our names out there as an organization.

### Conclusion

This was a successful year all things considered, as we did what we knew we could very well and worked on trying out new events to broaden the scope of what we do. Being a few years past COVID at this point, our institutional knowledge is much greater than it was then, giving me hope that those who come after me will have an easier and clearer vision on what it takes to serve the bands than I did just a few short years ago.

# 2022-2023 Iota Kappa Chapter Report Boise State University

### Introduction

This year brought so many amazing things you will read about in this report, and know that the steps are being taken to make this only better as time goes on. The height we strove for this year was not where it should have been, but it is only a stepping stone to allow the future of this Chapter to strive for the highest heights it has seen yet.

### Chapter Function

Just over a year ago, our Executive Officer Board officially convened for the first time. We went over a collection of our Chapter's anonymously submitted thoughts to questions such as "Did you feel like you belonged in this Chapter this year", "How do you believe our Chapter succeeded and failed this year", and more. These built the framework of how we planned our operations this year. We made sure that our Chapter meetings were efficient and meaningful, we continued to have strength in our service projects in both quantity and quality, and we took strides to help everyone feel welcome in our Fraternity. ### Brotherhood

Our Brotherhood this year was strong, but not necessarily out of having a large amount of planned events. While we are looking to have a better brotherhood calendar this upcoming year, I believe it is important to share the positive things that still happened this year. The Brothers of the Iota Kappa Chapter hang out very regularly outside of Chapter functions, in so many different aspects. We take classes together, to ensure each other's success and enjoyment of the class. We eat together, many of us are able to share meals multiple times a week with Brothers. We live together, we trust each other and

become connected in so many aspects of each other's lives. These are not the stories of overarching Chapter-wide Brotherhood I would wish to be sharing, but it is important to notice the individual connections. I am so proud to confidently say that each of our Brothers would when asked who their closest friends are would list at least one Brother.

That all being said, we did have Brotherhood Events that I would like to share. We held our traditional events during recruitment, going to Zoo Boise and hiking Table Rock together. An event we have yearned for as a Chapter was a "Color Guard Tech Day" taught by our Brothers in the Guard of Blue Thunder. This year we finally got to have it, and it was a wonderful time to share musicianship in a new way for some Brothers. We also held recurring events such as KKSports and KKStudy. These were not done as regularly as we would like, but we were able to see how we would like these projects to move forward into next year.

#### Service

Our Vice President of Service was able to use his strengths in building connections to get our Chapter great opportunities to serve. He got us into our community in new and exciting ways including helping with a marching band competition aside from our regular one, who has now asked for volunteers for future years. We also now regularly help the Meridian Symphony Orchestra run their concerts acting as ushers and various roles depending on their need. These projects serve the greater purpose of our university bands, to build up music in the Treasure Valley.

We served our university bands in direct ways this year as well. We did our regular "Freshman Move-In" project to help new members of Blue Thunder get moved in before Band Camp and establish a connection with someone in the band before even setting foot in the Band Hall. We cleaned shakos for the Marching Band for the first time in a few years, allowing our band the professional look it should have. We helped organize the music libraries of our Symphonic Winds, All Campus Concert Band, and Blue Thunder Marching Band.

The projects that have become recurring that help our community were executed to great success this year. We had the longest D3 Marching Band competition as it moved to a preliminary and finals format. We still ensured that all bands had a guide, all gates had ushers, tickets were being sold, and the other countless jobs needed to run a successful large scale service project. Our volunteers with the high school Band Clinic, D3 Solo and Ensemble Festival, and Gene Harris Jazz Festival were also mightily thanked for their service.

Other events we held include running recitals, helping with Audition Days, doing set up for various band concerts on our campus, and more.

Along with these organized service projects, I want to highlight the culture of our Brothers doing service on their own. Brothers have stepped into various different situations that needed help and were there and ready to do so. These include things like helping a group that was missing their photographer all the way to doing amazing things for the Treasure Valley like being highly involved in the staff of the new Boise Gems DBC including the Vice President and Brass Caption Head, two Guard Caption Heads, and two administrative roles.

## Musicianship

This year the musicianship of our Brothers was shown greatly in our ensembles. All but two ensembles related to band on our campus had at least one Brother in it this list includes Symphonic Winds, All Campus Concert Band, Jazz Orchestra, Symphonic Orchestra, Clarinet Ensemble, Trumpet Ensemble, Trombone Choir, Tuba Euphonium Ensemble, Marching Band, Pep Band, and a number of chamber groups.

Over the summer, our Chapter took part in a large, pillar-oriented event called Summer Retreat. During this retreat, our Music Chair led a musical event called "Kazoo Choir", where each Brother learned a part different from their own to one of our pep band songs. This has become a recurring event for our Chapter and still provides the same simple joy and connection as before. While this event was comical and fun to participate in, it helped some Brothers in their sight-reading skills, understanding one another's part, and getting to perform something they never have before. The end result was entertaining and successful for the retreat.

### Leadership

Before WDC began, I truly did not know what to share regarding our Chapter's leadership. Obviously I knew I wanted to share that we have many Brothers in leadership positions this year and next in Blue Thunder. I also wanted to share how the majority of our Chapter leadership comes from our 2021-22 recruiting class showing the success of that year and the direction of our Chapter. Making sure to include that all four winners of "The Living Legacy Award", the highest honor the Blue Thunder bestows to its members were Brothers. But, it just didn't feel like enough, I needed to highlight more people.

This Convention brought so much opportunity for our Brothers to better their leadership, just by being there. We were able to bring 13 Brothers to convention, not including the 2 District Officers from Iota Kappa. For 10 of them this was their first Kappa Kappa Psi Convention, and all of them have shown me

that spark that comes from going to your first convention. Some of these Brothers have found new passion to serve their District and their Chapter, some have developed a want to develop connections with our Sisters, some showed me a new sense of understanding they did not previously have regarding our functions. These are all examples of leadership I am so excited to share, and I thank you all reading this to create this spark in my Chapter. I see much more Iota Kappa in the future of our National and District affairs.

### **Fundraising**

This was a year that has featured two Treasurers for the Iota Kappa Chapter, due to unfortunate circumstances. Despite this we held two very successful large scale fundraising projects as well as a fundraising project put on by our new recruiting class.

We have the privilege to be commissioned with putting together the T-Shirts for the D3 Marching Band Competition, our area's final competition where high school students get to perform on The Blue Turf. This fundraiser is always successful and provides students and families with a sense of pride with a piece of merchandise they can buy to show off their achievements.

Our recruiting class put together an apple cider and hot cocoa booth over the course of the first week back from Winter Break. They successfully saw what it takes to logistically work with our Student Organizations on Campus and create a fundraiser, while also making our Chapter money!

Lastly, our merch at WDC this year! This was the flagship project of our newly elected Treasurer for this semester, and it was an amazing success. We pulled together the efforts of multiple Brothers in our Chapter with skills in painting, sticker printing, 3D printing, and laser cutting to create new and original merch for this convention. We organized all proper commissions so these Brothers are compensated and get the professional experience to be recognized for their time and effort financially.

#### Intro

#### Service

Iota Pi has been dutifully working this year to provide service to our college's band programs. We have continued to assist with washing water bottles for the Mustang Band before each of Cal Poly's football games. We also have completed two instances of "Armoryfest", our quarterly tradition of cleaning and organizing the storage unit for our school's bands, with plans to do it a third time later this quarter. This project is integral to tidying all of the clutter that accumulates over each quarter's extensive use by our drumline, equipment and uniform managers, and Mustang Band assistant Len Kawamoto.

In preparation for the Mustang Band's trip to participate in the San Francisco Chinese New Year Parade, we helped clean our members' shoes by holding shoe cleaning sessions after each marching rehearsal. While the sessions were impacted due to the heavy rain San Luis Obispo was experiencing, we were still able to get many pairs of shoes looking pristine. # Membership and Recruitment

Recruitment took its form this year in the form of mixed in-person and online events this year.
